No [] *If not, please make arrangements to provide the marina with any keys required to move your boat for the haul out and ensure that it has been pumped out in advance. Harbour Lights will not take responsibility for any expense/damage resulting from the failure of the owner to insure his boat has been pumped out in advance of haul out*
- Due to the amount of time required to move your vessel, remove and store all dock lines and power cords, there will be a \$200.00 charge if you or a representative is not present during any haul out, launch or lift. Further it is your responsibility to attend at the marina within 48 hours to confirm that your boat has been handled satisfactorily and is either moored properly following a launch or is blocked to your satisfaction following a haul out. Failure to do so releases Harbour Lights Marina from any liability for damages alleged by you to have been the direct result of the said service provided.
- All boats must be PUMPED OUT prior to haul out for winter storage. In the event the boat has not been pumped out prior to the scheduled haul out time the boat will not be removed from the water and a new haul out date/time will have to be arranged.
- For insurance purposes it is important that a contract is filled out completely and signed by the captain prior to any haul out or launch. Payment in full must be made prior to any such haul out, launch or lift. We accept Visa, Master Card, debit card, cheque or cash.
- All sailing vessels must haul out onto an approved steel cradle.
- The Owner assumes liability for all claims arising as a result of the damage, injury or death to property or persons of Harbour Lights, its servants, agents, employees, customers or tenants, or their guests, resulting either directly or indirectly from the Owner's negligence. The use by the Owner of the facilities of Harbour Lights shall be at the sole risk of the Owner, and the Owner covenants to indemnify and save harmless Harbour Lights, its servants, agents or employees, against any claim for loss or damage arising out of the use of the marina facilities or equipment or the handling of any boat anywhere on the marina property by the Owner or his servants, agents or employees.
- It is further agreed that the Owner will insure his boat for the full value as well as carry Liability Insurance Coverage.
- The Owner agrees to observe and abide by the rules and regulations as posted by Harbour Lights on the Harbour Lights premises from time to time.
