1. **THIS CONTRACT MUST BE DATED, SIGNED AND RETURNED AND YOUR TOTAL MUST BE PAID IN FULL BEFORE YOU ARE SCHEDULED FOR A LAUNCH DATE**, please contact Harbour Lights office at 519-565-5150.
2. a) Will you or a representative acting on your behalf be present for your launch? **YES [] NO []**
b) If not, do we need keys for your boat? **YES [] NO []** Mooring lines and fenders must be available or Harbour Lights will supply them at a charge to the owner.
3. **Due to the amount of time required to move your vessel, remove and store all dock lines and power cords, there will be a \$225.00 charge if you or a representative are not present during and haul out, launch or lift. Further, it is your responsibility to attend at the marina within 48 hours to confirm that your boat has been handled satisfactorily and is either moored properly following a launch or is blocked to your satisfaction following a haul out. Failure to do so will release Harbour Lights from any liability for damages alleged by you to have been the direct result of the said service provided.**
4. **For insurance purposes it is important that a contract is filled out completely and signed by the captain prior to any haul out or launch.** Payment in full must be made prior to any such haul out, launch or lift. We accept Visa, Master Card, Debit Card, Cheque or Cash.
5. **It is understood and agreed that in the event the vessel does not launch or leave the property before the end of May a dry-dock storage charge of \$200.00 per month plus applicable taxes payable in advance will be charged for the months of June, July, August and September and will continue at that rate until such time as the customer enters into a new contract for winter storage with Harbour Lights Marina.**
6. **It is further understood and agreed that should the owner fail to pay the storage costs as invoiced within 60 days the owner will be deemed to be in default of the contract; the boat will be deemed to have been abandoned and Harbour Lights Marina will be at liberty to dispose of the said vessel either by sale or other means and apply any monies collected to the payment of the outstanding storage costs or other fees associated with the said disposal.**
7. The owner assumes liability for all claims arising as a result of the damage, injury or death to property or person of Harbour Lights, its servants, agents, employees, customers or tenants, or their guests, resulting either directly or indirectly from the Owner's negligence. The use by the Owner of the facilities of Harbour Lights shall be at the sole risk of the Owner, and the Owner covenants to indemnify and save harmless Harbour Lights, its servants, agents, and employees, against any claim for loss or damage arising out of the use of the marina facilities or equipment or the handling of any boat anywhere of the marina property by the Owner or his servants, agents or employees.
8. It is further agreed that the Owner will insure his boat for the full value as well as carry Liability Insurance Coverage.
9. **The Owner agrees to observe and abide by the rules and regulations as posted by Harbour Lights on the Harbour Lights premises from time to time.**
