## PLEASE NOTE:

1. The Owner assumes liability for all claims arising as a result of the damage, injury or death to property or persons of Harbour Lights, its servants, agents, employees, customers or tenants, or their guests, resulting either directly or indirectly from the Owner's negligence. The use by the Owner of the facilities of Harbour Lights shall be at the sole risk of the Owner, and the Owner covenants to indemnify and save harmless Harbour Lights, its servants, agents or employees, against any claim for loss or damage arising out of the use of the marina facilities or equipment or handling of any boat anywhere on the marina property by the Owner or his servants, agents or employees.
2. It is further agreed that the Owner will insure his boat for the full value as well as carry Liability Insurance Coverage.
3. The Owner agrees to observe and abide by the rules and regulations as posted by Harbour Lights on the Harbour Lights premises from time to time.
4. It is understood and agreed that in the event the vessel does not launch or leave the property before the end of May a dry-dock storage charge of \$150.00 per month plus applicable taxes payable in advance will be charged to the months of June, July, August and September and will continue at that rate until such a time as the customer enters into a new contract for winter storage with Harbour Lights Marina.
5. It is further understood and agreed that should the Owner fail to pay the storage costs as invoiced within 60 days he will be deemed to be in default of his contract; the boat will be deemed abandoned and Harbour Lights Marina will be at liberty to dispose of the said vessel either by sale or other means and apply any monies collected to the payment of the outstanding storage costs or other fees associated with the said disposal.
